NOTE:

The reduction percentage indicates the percentage of a student’s assessed tuition that will be reversed based upon their withdrawal date from the session.

Example: Student’s per credit hour enrollment totals \$25,000 in tuition assessed for Regular Session classes prior to withdrawal.

Reduction percentage based upon withdrawal date for the Regular Session = 40%.

Student will be responsible for 60% (100%-40%). $\$25,000 \times .60 = \$15,000$.

There is no proration for dropped classes after the end of the add/drop/swap period.
